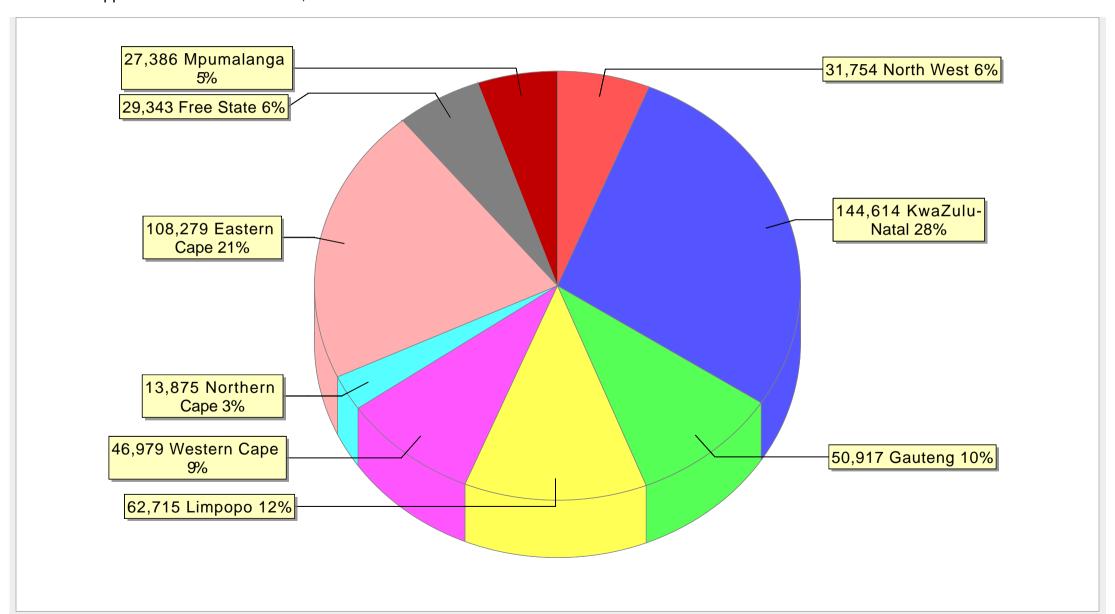

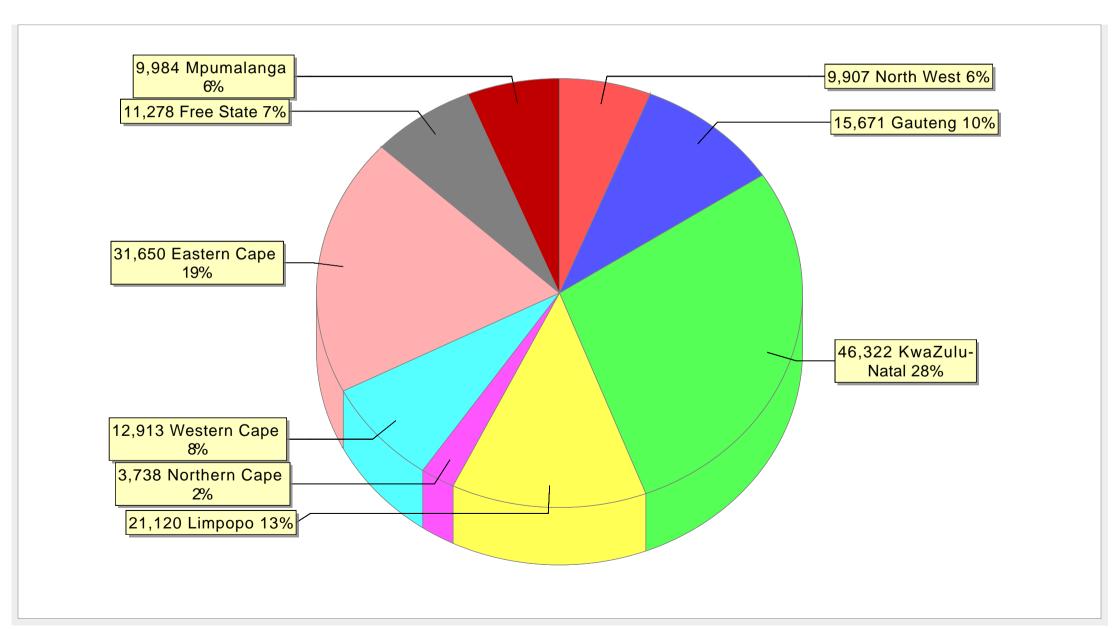

Total Work Opportunites created: 515,862



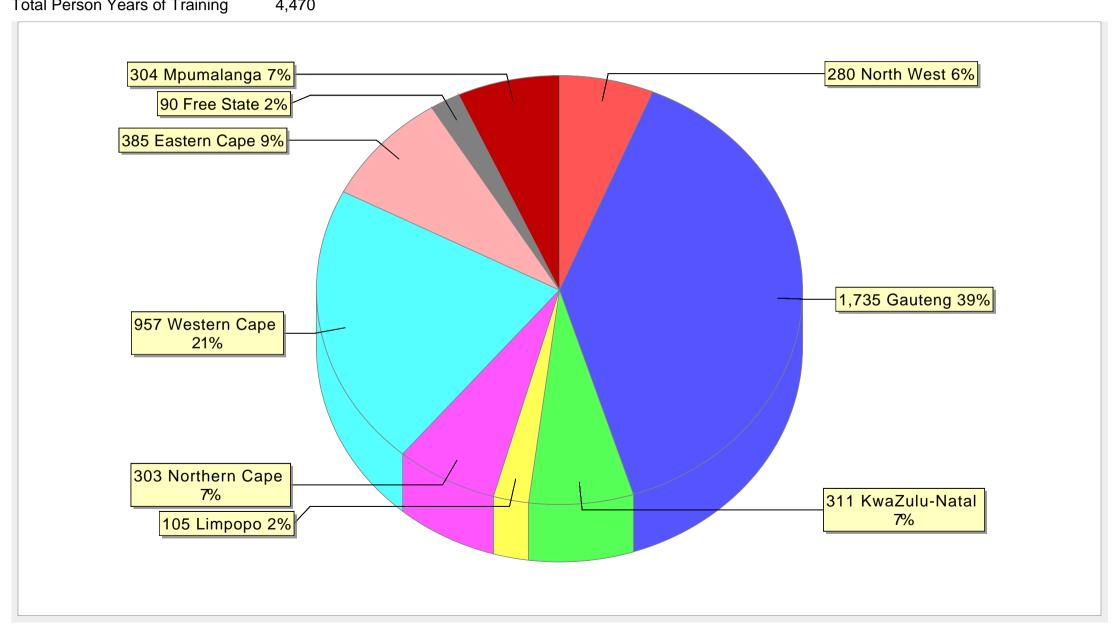
